**No. 18/77/2015-3C1:-** In exercise of powers conferred by the Sub-Section (1) of the Section 3 of the Haryana Municipal Act, 1973, the Governor of Haryana hereby proposes to declare the area as per schedule given below to be Municipality, in the name of Municipality Radaur in District- Yamunanagar

Notice is hereby given that the draft will be taken into consideration after the expiry of six weeks from the date of publication of this notification in the Official Gazettee together with any objection and suggestion which may be received by the Principal Secretary to Government Haryana, Urban Local Bodies Department through the Deputy Commissioner, Yamunanagar from any person in respect of this draft notification as required vide sub-section (5) of the aforesaid section.

**SCHEDULE OF BOUNDARIES**

**North:-** Starting from the west north boundary of Bapoli Road which is situated on the western corner of Khasra No118, then moving towards north alongwith the revenue estate of village Radaur Hadbast No.45 upto the point of saheda of village Radauri Hadbast no 44, Chhota Bans Hadbast No.43, which is also situated at Khasra No.1113 of Hadbast No.45, then from this Saheda which is also situated on khasra No. 151 of Hadbast No.43, moving towards north alongwith the revenue estate boundary of hadbast No.43 upto the point of Saheda of village Radauri ( Hadbast No.44) village bakana ( Hadbast No.40) which is situated on Khasra No. 1 of Hadbast No.43. Then moving towards east alongwith the revenue boundary of Hadbast No.43. then moving towards east alongwith the revenue boundary of Hadbast No.43 upto the point of Saheda of village Kanjnu Hadbast No.42) village Ratangarh Hadbast No.10 which is also situated on Khasra No. 676/2 of Hadbast No.43.

**East :-** Starting from the above Saheda situated at Khasra No. 676/2 then moving towards south alongwith the boundary of revenue estate of Hadbast No.43 of village chota

bans, upto the point of Saheda of village Radaur Hadbast No.45 village Ratrangarh Hadbast No.10 which is also situated at Khasra No.747 of Hadbast No.45. Then moving towards south alongwith the revenue boundary of Hadbast No.45 upto the point of saheda of village Nachraun Hadbast No.9 and village Bhagwangarh Hadbast No.11 which is also situated at Khasra No.2121 of Hadbast No.45.

**South:-** Starting from the above Saheda situated at Khasra No. 2121, then moving towards west alongwith with revenue boundary of Hadbast No.45 village Radaur upto the point of Saheda of village Bapoli Hadbast No. 52 village Dholra Hadbast No.47 which is also situated on Khasra No.43 of Hadbast No.45.

**West :-** Starting from the above Saheda situated at Khasra No.430 then moving towards north alongwith the revenue boundary of Hadbast No.45 upto the south west corner of Khasra No.118 of Hadbast no.45 which is starting point.

संख्या 18/77/2015-3क1:-हरियाणा नगर पालिका अधिनियम, 1973 (1973 का अधिनियम 24), की धारा 3 की उपधारा (1) द्वारा प्रदान की गई शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा नीचे दी गई अनुसूचि में विनिर्दिष्ट स्थानीय क्षेत्र को जिला-यमुनानगर में नगर पालिका, रादौर के नाम से एक नगर पालिका घोषित करने का प्रस्ताव करते हैं।
