Sealed tenders are invited from firms or their authorized dealers for the Supply, Installation, and Maintenance of IP Based 1.3 Mega Pixel CCTV Cameras for City Surveillance in the area of Municipal Corporation, Rohtak having adequate experience of the said job. Maintenance of the said job is for 5 years in all respects, **Bids will be received** up to 01:00 PM on **09-07-2014** in the office of Executive Engineer -I, Municipal Corporation Rohtak.

General Instructions:-

1. The tender forms, terms & conditions of the contract, general instructions to the tenderers and other relevant information can be obtained from the office of Electrical Branch, Municipal Corporation Rohtak on any working day from 9.00 AM to 5.00 PM upto last date of sale of tender which is 08-07-2014. The cost of tender document is Rs.1000/- which is non-refundable. The tender not submitted on prescribed forms and not within the prescribed time is liable to be rejected.
2. The tender should be submitted in a sealed cover subscribed as **MCR/Electrical/2014/ IP Based CCTV Cameras** so as to reach the office of Executive Engineer -I, Municipal Corporation Rohtak on or before **09-07-2014** upto **01.00 PM** and the same shall be opened on the same day at **3.00 P.M** in the presence of the bidders or their authorized representatives who may choose to be present. The separate sealed envelope containing Financial Bid and Technical Bid should be placed inside the main sealed envelope. Each envelope should be clearly subscribed as Financial Bid and Technical Bid respectively to avoid any confusion during opening.
3. The cost of tender documents is Rs. 1000/- (Rs. One Thousand only) to be deposited in the shape of Demand Draft in favour of Commissioner, Municipal Corporation, Rohtak or in Cash. Tender Cost will not be refunded
4. Only those bidders with a minimum average annual turnover of Rs. **25 lacs** for the last three years shall be eligible to participate in the bidding process. The work order, payment details and a certificate from a Chartered Accountant in this regard and showing the minimum turnover shall have to be submitted with the bid.
5. The bidder must have worked for a minimum of three years with a Government/Municipal Corporation/Semi-govt. department. A satisfaction certificate for a period of three years from the concerned department must be submitted with the bid. Contractor should have experience of maintenance of IP Based CCTV Cameras for City Surveillance.
6. He is required to submit the list of its supervisors along with their complete particulars and photographs along with the bid who will be present in city for maintenance of the said job for full weekend and he will not leave the city without the prior permission from the office of Commissioner, Municipal Corporation Rohtak.
7. The bidder must sign all papers and documents accompanying the tender and should also attest on all corrections in the tender as regards rates, completion period etc. Non-compliance shall result in rejection of the tender.
8. The tender should be submitted in one part. No subsequent amendment shall be considered. Conditional tenders are liable to be rejected.
9. The firms or their authorized dealers are advised to visit the site to acquaint them fully about the work involved and the prevailing conditions before submission of tender. No claim whatsoever shall be entertained from the firms or their authorized dealers later on for any conditions being difficult or his claim of ignorance with regard to the area and scope of work.
10. The firms or their authorized dealers are advised to contact the Electrical Branch, Municipal Corporation Rohtak for visit to the area or any such queries and clarifications about the work involved and the prevailing conditions before submission of tender.
11. The firms or their authorized dealers shall abide by all Labour Acts and Rules / Regulations as framed by the Govt. (amended from time to time) and the non-compliance of the same shall

make the bidder liable for all the consequences arising out of the same.

12. The firms or their authorized dealers will provide all necessary site facilities to the workmen employed by him, including all kind of safety equipments required for the job.
13. The firms or their authorized dealers will maintain necessary records as required under labour regulations and make available the same for inspection by competent authority of Municipal Corporation Rohtak.
14. In order to cope with the obligations as per Labour Act, the contractor shall obtain workman's compensation insurance policy from an approved insurance company to cover up the risk of injury /death of the contract labour engaged by him at site if covered under act. The labour regulation shall be deemed as part of the contract and breach thereof shall be deemed as breach of contract. Accordingly the contractor will render himself for penal action for omission and commission on his part by the competent authority. The firms or their authorized dealers will have to open EPF, GIS accounts and shall generate challan and submit the same to MCR by the 7th of each month and MCR would in turn under EPF, ESI shall not be payable to the contractor and only wages along with the service charges would be payable.
18. The tender document is required to be submitted with an Earnest money amounting to Rs. 100000/- (Rs. One Lacs only) in the shape of Demand Draft in favour of Commissioner, Municipal Corporation Rohtak. The earnest money of the successful bidders shall remain with the Municipal Corporation Rohtak for the entire contract period and shall not carry interest.
19. The EMD will be forfeited if the tenderer withdraws the tender after opening of tender and in case of a successful tenderer, if the tenderer fails within the specified time limit to sign the agreement.
20. The firms or their authorized dealers shall confirm acceptance of all general instructions and terms & conditions of the contract supplied as part of tender documents.
21. Commissioner, MCR reserves the right to reject any or all the tenders without assigning any reason.

SECTION 3

CONDITIONS OF CONTRACT:-

1.0 INSTRUCTIONS:-

1.1 Municipal Corporation Rohtak intends to hire the services of an established & experienced agency for Supply, Installation and maintenance of IP based CCTV cameras for city surveillance under Municipal Corporation, Rohtak and AMC for a period of five years i.e. ***(which can be extended yearly for further next years with the approval of Ld. Commissioner Municipal Corporation Rohtak after analysis of performance of the agency)***

2.0 DEFINITIONS OF TERMS:-

2.1 Definition & meaning of various terms and expression used in contract document are given at Annexure-1 enclosed herein.

3.0 SCOPE OF WORK:-

Works Included: The scope of work has been covered in the specifications in general however, the Successful Bidder shall be responsible to complete the works in all respects and in doing so, provide/supply all facilities not covered above specifically, but nevertheless required for the satisfactory performance of complete system.

Works excluded: Existing watchtowers, light poles, Building tops can be considered for mounting camera and other equipment. Additional poles/towers etc if required will be paid separately.

4. Standard contract/Operating/Payment terms:-

The successful bidder should maintain the whole system on an ongoing basis, during warranty period of one year & subsequently during the comprehensive annual Maintenance contract (AMC) after the completion of warranty period for 5 years. During warranty period all materials/ parts/ services as required to maintain the system on an ongoing basis is included in the scope of the job and no extra payment will be made by Municipal Corporation, Rohtak.

The Successful bidder shall provide service support during business hours, if and when required, besides such other support like a 24/7 telephonic assistance etc., as may be required so that the system operates on a continuous basis.

The successful bidder will be the single point contact for Municipal Corporation, Rohtak for all support related issues with respect to hardware/software installed by them. If any third party help is required in resolving any issue, it will be the sole responsibility of the bidders to arrange for such help.

The period of project completion shall be 1 (One) Month from the date of Work order.

Payment Terms:-

Payment will be made after successful completion of the work order in prescribed period. 10% security will be deducted from each bill and same will be refunded after One year after successfully completion of warranty period.

The AMC payment shall be made at the end of every quarter after the beginning of the AMC period as divided from annual payment in four quarter. If the complaint will not rectified within 24 hours then the 5% Payment will be deducted in shape of Penalty from the quarterly payment.

The bidder will have to enter into a service level Agreement with Municipal Corporation, Rohtak containing the system performance & service related issues. The expected values of the parameters are as follows:-

- I. Guaranteed system Uptime 99%
- II. Network Availability 99%
- III. Latency (System) <150ms
- IV. Bandwidth:~ 3-5 MBPS per Camera (To be determined by the bidder for the required viewing/storing parameters)
- V. Scheduled Service: Once in a Month
- VI. Critical Service Response time 24 Hours

5. Performance Bank Guarantee:-

The Bidder (s) with whom the contract is decided to be entered into and intimation so given will have to make a performance bank guarantee inclusive of Security Deposit for an amount equivalent to 10% of the Purchase Order/Contract value (excluding the AMC and the recurring charges), Which shall be valid for a minimum period of eighteen (18) Months. The bank Guarantee on stamp paper of requisite value shall be accepted only from Scheduled Indian Banks (other Than Co-operative Bank). All Bank Guarantees shall be unconditional and encashable on presentation to the issuing bank. On receipt of CPBG, the EMD of the bidder will be returned.

In Case successful bidder fails to submit a valid CPBG of required amount within 15 days from the date of intimation of acceptance of its tender, Commissioner, Municipal Corporation, Rohtak, reserves the right to cancel the order and forfeit its EMD.

6. Delay in Completion/ Liquidated Damages:-

Timely execution is extremely critical in the case of this project. Execution of the project shall include supply, installation, commissioning, training & stabilization of the system in all respects. In case of delay in execution of the order beyond contracted delivery date as stipulated in the order Municipal Corporation, Rohtak at its option can either:-

- i. Accept the delayed delivery on price reduced by sum equivalent to half percent (0.5%) of basic PO Value (excluding CAMC) per week of delay or part thereof, subject to a maximum of 5% of basic PO Value (excluding CAMC).
- ii. Cancel the order in part or full and purchase such cancelled quantities from elsewhere on account at the risk of the seller without prejudice to its right under (i) above in respect of goods delivered. All costs and expenses incurred by Municipal Corporation, Rohtak, if any, resulting from cancellation of order shall be recovered from the seller.

7. Performance Testing and Warranty:-

The Successful Bidder shall carry out the performance test run of the complete system at site after satisfactory installation/implementation under his supervision. Training of operators should be as per details mentioned in this document after commissioning of the system without any extra cost to Municipal Corporation, Rohtak.

The system provided should be guaranteed/warranted for any kind of manufacturing defects and satisfactory performance for a period of 12 months from the date of acceptance /final sign off obtained from concern official of Municipal Corporation, Rohtak.

8. Comprehensive Annual Maintenance Contract (AMC) Post Warranty

- i. Complete system will be covered under post warranty Comprehensive AMC as per Rates quoted in the price bid for a period of 60 months from the date of completion of warranty. The post warranty comprehensive AMC shall be a separate annual contract for each of the 5 years period and shall be signed at beginning of the respective period. The post warranty comprehensive AMC rates quoted in price bid for 5 years shall be included in the evaluation.
- ii. During the post warranty comprehensive AMC period all software/Services etc. as Required to rectify any defect, will be provided by the successful bidder at no extra cost to Municipal Corporation, Rohtak. Material/hardware /spares as required for such maintenance would also be provided by the bidder. No extra amount is payable by Municipal Corporation, Rohtak for this post warranty AMC other than quoted AMC rates.
- iii. Comprehensive AMC comprises of the following services as a minimum
 - a. Routine maintenance service: This is an onsite maintenance, which should be carried out four times in a year. Purpose of visit is to check system health and problem solving.
 - b. Breakdown maintenance service: In case of system breakdown, Successful bidder shall depute Engineers to restore the system at the earliest, within 24 Hours.
 - c. Software support and technical services: Software additions / modifications, technical assistance to Purchaser's Engineers, technical discussions with Purchaser's Engineers /Technicians at successful bidder's facility etc. are included.
 - d. For the entire period of the project, which includes the defect liability period of 1 year and the 5 years AMC, the bidder shall depute at least one person who shall be placed in the control

room and who shall be responsible for the daily maintenance of the system. The charges for this person shall be included in the AMC charges. The personnel deployed to site shall have thorough knowledge of the system and at least two years of experience in maintenance of similar system. An experience certificate to this effect to be handed over to the Project Consultant.

- e. Quarterly payment of finalized AMC amount will be made after successful completion of period of respective post warranty AMC, should Municipal Corporation, Rohtak enter into AMC for that respective year.
- iv. Commissioner, Municipal Corporation, Rohtak reserves the right to order for the post warranty AMC along with the main order or after the completion of the warranty period of one year, and such decision solely is at Commissioner, Municipal Corporation, Rohtak discretion. Commissioner, Municipal Corporation, Rohtak reserves the right to sign the post warranty AMC for all 5 years or part of it or none.

9. Bank Guarantee for AMC

The vendor shall furnish AMC Bank Guarantees (BG) equivalent to 10 % of AMC value. The AMC BG shall be submitted to the Commissioner, Municipal Corporation, Rohtak before the expiry of warranty period failing which the Performance Bank Guarantee shall stand forfeited. The AMC BG shall be valid for a minimum period of 60 months.

10. Upgrades

Any upgrades to software with respect to firmware and revisions during the period of contract, warranty and AMC should be provided by the successful bidder at no extra cost to Municipal Corporation, Rohtak.

11. Training And Handholding

The Successful Bidder will train Municipal Corporation, Rohtak personnel at two levels

- a. Training for the control room operator and security staff .
- b. Training for Municipal Corporation, Rohtak supervisory staff

12. Scalability

The system design shall permit the online addition of new system /subsystems (new work station, peripherals, cameras, encoders etc.) with no disruption to either the operation or system communications for future expansion. The offered software should have inbuilt capability / provision to take care for future expansion and new services & features etc. The user configurable menu driven modules should be available in the software for any addition/deletion/change in the Plant configurations. No hard coding is allowed for the above functionality. Surveillance System should be scalable to meet additional business, safety and security requirement of the Municipal Corporation, Rohtak. The system should be scalable to interface with Municipal Corporation, Rohtak network /Switches. All system communications shall be based on the ISO, Open system Interconnect (OSI) reference model. All communication solutions should be Ethernet Based.

13. Municipal Corporation, Rohtak Deliverables /Scope

Municipal Corporation, Rohtak shall make available the sites to the Successful Bidder to carry out the job from administrative point of view. Successful Bidder should specify the space requirement as infrastructure for implementing his system based on which, Municipal Corporation, Rohtak shall ensure adequate space for placing the equipment.

14. System Acceptance Criteria

The system will be accepted by Municipal Corporation, Rohtak based on the following criteria:

- All systems to be verified operational as defined in the Scope of Work above.
- Surveillance System installed and functioning, as described in the FDS submittal.
- All manuals and drawings are delivered to Municipal Corporation, Rohtak.

- All software licenses are delivered to Municipal Corporation, Rohtak. Master Server license, Software analytics license, camera licenses, AVL license should be handed over to Municipal Corporation, Rohtak.
15. Commissioner, Municipal Corporation, Rohtak reserves the right, at its sole discretion, to request clarifications of technical proposals or to conduct discussions for the purpose of clarification with any or all Bidders. The purpose of any such discussions shall be to ensure full understanding of the proposal. Discussions shall be limited to specific sections of the proposal identified by the Municipal Corporation, Rohtak and, if held, shall be after initial evaluation of Technical Proposals. If clarifications are made as a result of such discussion, the Bidder shall put such clarifications in writing.
- 16. The Project Consultant may request:**
- a. An interview and/or open forum meeting with the technical teams of the Bidders or the OEMs.
 - b. A visit to the OEM facilities or reference sites as per the benchmarking schedules set with the individual bidder/s.
 - c. A reference checking meeting with the clients referred to by the Bidder.
 - d. A visit to the office/facilities of the bidder.
 - e. OEM Should have running office in India.
17. For this purpose, an adequate notice of at least 7 days in advance shall be provided.
18. Commissioner, Municipal Corporation, Rohtak reserves the right to make changes in the quantities of the material sought OR to procure the goods in deferred stages OR to cancel the purchase of any of the items specified in this Tender Document OR to divide the order to more than one vendor. As a part of the technical process, the bidders shall be required to demonstrate their solution by carrying out a Proof of Concept (POC) at their own costs at a location specified by Municipal Corporation, Rohtak in MC, Rohtak City. The purpose/objective of the POC shall be to determine that the solution proposed by the bidder meets the overall functional & technical requirement of the project. A notice of 7 days shall be provided for this purpose. Please note that a successful POC is a prerequisite for technical qualification in the tender process. The POC will be conducted with the exact same set of equipment / software / makes proposed by the vendor and will be based on functional capabilities of the vanilla version of the software proposed.
19. The commercial bids of only those companies that successfully meet the PQC & technical criteria (including the POC Criteria) will be evaluated.
20. The commercial evaluation will be based on the Total Delivered Cost (including Capital & Operational expenditure) to Municipal Corporation, Rohtak calculated for a period of 5 years for the entire project.
21. Municipal Corporation, Rohtak reserves their right to negotiate the quoted prices with the selected bidder.
22. Municipal Corporation, Rohtak reserves the right to delete any of the items in the Schedule of Rates at the time of placement of Purchase Order. The decision of Commissioner, Municipal Corporation, Rohtak shall be final and binding in this respect.

7. Month shall mean the calendar month. Day of days unless herein otherwise expressly defined shall mean calendar day or days of 24 hours each.
8. Writing shall include any manuscript, type written or printed statement under or over signature and or seal as the case may be.
9. When word “approved” “subject to Approval” “Satisfactory” “Equal to” “Proper” “Requested”, “As directed”, “Where Directed”, “When directed”, Determined by”, “Accepted”, “Permitted”, or words and phrases of like importance are used, the approval judgment, direction etc. is understood to be function of Municipal Corporation Rohtak.
10. “Contract period” shall mean the period during which the contractor shall remain liable for the performance of work as per the terms and contract/Letter of Award.
11. Words imparting the singular only shall also include the plural and vice versa where the context so requires.
12. The term “Contract Documents” shall mean the Letter of Award along with its enclosures and attachments which shall be deemed to form an integral part of the contract.
