As you are aware that Municipal Corporation Rohtak has been formed vide Govt. Notification No 18/06/2010-3 C1 dated 17-03-2010 As per Section 330 of Haryana Municipal Corporation Act 1994. It is mandatory for the owner etc. of a Factory/ Workshop or trade premises to obtain a license from the Corporation U/S 330 of the act. The annual license fee prescribed by the govt. for this purpose is on the basis of financial turnover of the previous Year. The application for license has to be made to the Municipal Corporation before 1st April every year. In view of the peculiar situation of the Corporation, Rohtak having come into being in March -2010 it is understandable that you have not applied for the said license till now. You are therefore, requested to make a simple application on your official stationery for the issue of your license for the year 2010-11 and 2011-12 with in seven days positively after receipt of the notice. (application form attached).

The requisite fee can be calculated by your self as per the table given below
